NOW THEREFORE BE IT RESOLVED THAT Council for the Municipality of Mattice – Val Côté hereby supports Resolution no. 042-2023 made by Council for the Township of Moonbeam, requesting that the provincial government, through the Minister of Education, extend the moratorium on most pupil accommodation reviews, in order to allow municipalities, townships, neighborhoods or subdivisions the opportunity to prosper, develop and grow, without being hindered by the prospect of school closures because of current low enrollments that could quickly change, and;
