Shortage of child care spaces

<u>Resolution 23-163</u>: Steve Brousseau – Réginald Manning WHEREAS there is an extreme shortage of child care spaces across the Province:

NOW THEREFORE BE IT RESOLVED THAT Council for the Municipality of Mattice – Val Côté hereby supports the resolution made by Council for the Town of Petrolia on June 26th, 2023, recommending to the Honorable Stephen Lecce, Minister of Education, that in time for the 2023 school year, amendments to the current legislation be made to allow licensed home-based child care operators the ability to provide two (2) before and after school care spaces to school aged children, in addition to the permitted six (6) full time child care spaces, and;

BE IT FURTHER RESOLVED THAT in an effort to attract and retain qualified early childhood educators, the Minister of Education review the current wage bracket for early childhood educators and implement an increase to wages to align with the services provided, and;

BE IT FURTHER RESOLVED THAT the Province provide more capital based funding sources for the construction of new centre-based facilities, and;

BE IT FURTHER RESOLVED THAT the Province consider increasing the current goal of thirty-three percent (33%) access ratio, to better align with the current provincial situation and the anticipated population growth over the next ten (10) years, and; BE IT FURTHER RESOLVED THAT these items be considered sooner than later to assist in remedying the critical child care shortage experienced in Petrolia, Lambton, and across the province, and;
