Mandatory closures of small businesses and inequity

Rent freeze

Resolution 21-07: Richard Lemay – Daniel Grenier

WHEREAS Consolidated Municipal Service Managers and DSSABs rely on rent revenue to offset municipal costs associated with the downloaded housing portfolio, and;

WHEREAS Bill 204 has resulted in a rent freeze, thereby limiting the available revenue for municipalities;

NOW THEREFORE BE IT RESOLVED THAT Council for the Municipality of Mattice — Val Côté hereby supports Resolution no. 20-115 made by The District of Cochrane Social Services Administration Board, requesting that the Minister of Municipal Affairs and Housing exclude DSSABs from the rent freeze stipulated in Bill 204, and;

BE IT FURTHER RESOVED THAT a copy of this resolution be forwarded to the Cochrane District Social Services Administration Board and to our federal and provincial government representatives, Carol Hughes and Guy Bourgouin.

Municipal insurance premiums

Resolution 21-08: Joyce Malenfant – Richard Lemay

WHEREAS the cost of municipal insurance in the Province of Ontario has continued to increase, with especially large increases going into 2021, and;

WHEREAS Joint and Several Liability continues to ask property taxpayers to carry the lion's share of a damage award when a municipality is found at minimum fault, and;

WHEREAS these increases are unsustainable and unfair and eat at critical municipal services, and;

WHEREAS the Association of Municipalities of Ontario outlined seven recommendations to address insurance issues, including:

- 1. The provincial government adopt a model of full proportionate liability to replace joint and several liability.
- Implement enhancements to the existing limitation period, including the continued applicability of the existing 10 day rule on slip and fall cases, given recent judicial interpretations, and whether a 1 year limitation period may be beneficial.
- 3. Implement a cap for economic loss awards.
- 4. Increase the catastrophic impairment default benefit limit to \$2 million and increase the third party liability coverage to \$2 million in government regulated automobile insurance plans.
- Assess and implement additional measures which would support lower premiums or alternatives to the provision of insurance services by other entities such as non profit insurance reciprocals.
- Compel the insurance industry to supply all necessary financial evidence, including premiums, claims and deductible limit changes which supports it, and municipal arguments as to the fiscal impact of joint and several liability.
- Establish a provincial and municipal working group to consider the above and put forward recommendations to the Attorney General.

NOW THEREFORE BE IT RESOLVED THAT Council for the Municipality of Mattice – Val Côté hereby supports the motion made by Council for the Municipality of Charlton and Dack on December 18th, 2020, calling on the Province of Ontario to immediately review these recommendations and to investigate the unethical practice of preferred vendors who are paid substantial amounts over industry standards, despite COVID 19

delays, as insurance premiums will soon be out of reach for many communities, and;
